What are Supports Coordination Services?

- Development and maintenance of an Individual Support Plan (ISP).
- Determining the need for services and developing "outcomes."
- Identifying and locating providers of services.
- Coordinating waiver services when funding is available.
- Ensuring services are received as outlined in the ISP.
- Ensuring health and safety of those receiving services.

Who is eligible for services?

- Adults and children with a diagnosis of intellectual developmental disability.
 Documentation of IDD must include an IQ of 70 or below.
- Eligibility for certain services is dependent upon income and asset requirements.

 monitoring of the health and safety of
 people receiving supports and services
- To link consumers to services, resources, and benefits


